RE: Monthly Budget Variance Report for September 2019

Summary:

The budget variance report compares revenues and expenses to the respective line item budgets. The report identifies current monthly revenues and expenses as well as year to date (YTD) values. Most of the current monthly budget values are calculated by taking 1/12th of the annual budget and the YTD budget values are calculated by dividing the yearly budget by the number of months progressed through the fiscal year. The exception of the straight-line budgeting method is the passenger revenue which is budgeted using historical monthly trends.

• As of September 30, 2019, the organization's revenues net of subsidies are \$20,198 under budget or 1.9% under the YTD budget. Expenditures are \$1,036,236 under budget or 10.1% below the YTD budget.

Other Revenue - Unfavorable

- The unfavorable balance is mainly attributed to lower emission credit revenue.
- Emissions credit revenue has a negative variance due to a decrease in the number of credits of emission credits generated and sold.

Operator & Mechanic Salaries & Wages - Favorable

- The favorable balance is primarily attributed to vacant operator positions.
- Other factors include operators and mechanics using vacation time, sick time, short-term disability, and long-term disability.

Operator & Mechanic Overtime - Unfavorable

- Contributing factors for overtime usage include operators using vacation time, sick time, short-term disability, long-term disability. Also, there are some vacant positions. To cover actual workload, the active employees have to work extended hours.
- Budget is on a 1/12 straight line allocation, overtime expenditures follow a seasonal pattern and therefore some months will have larger variances than others.

Administration Salaries & Wages - Favorable

• The favorable variance in administrative salaries and wages is attributed to vacant positions across the agency (e.g., Maintenance Supervisor, Human Resources Manager, ZEB Project Administrator).

Administration Overtime - Favorable

• Administrative overtime is within an acceptable range of the budgeted amount.

Fringe Benefits - Favorable

- Fringe benefit savings are attributed to vacant positions across the agency and variable fringe benefit expenditures.
- Some fringe benefit expenditures are variable and occur at different times of the year (e.g., unemployment taxes, sick sell backs, 457 match contribution, health plan increase).

Communications - Unfavorable

- In September the unfavorable variance is due to a former telephone service contract. The new contract and upgrade was implemented 10/01/19 and a new billing rate established.
- In July an annual expense for a service fee for a real time cellular sign was paid.

Legal Services - Favorable

• Legal service fees are a variable cost that change depending on usage, the amount spent differs from month-to-month.

Computer/Network Software Agreement - Favorable

- Budget is twelve-period allocation, but some expenses are yet to be incurred (i.e., software programs).
- The following programs will be incurred in the latter part of the year:

Barracuda - provides web filters, spam filters, and email archive

Keystone - support for SYSCO devices

Cummins Software - utilize to run diagnostics on Cummins engines

Lansweeper - network management tool.

Uniforms - Favorable

- At the beginning of the fiscal year, operators are given a \$300 credit toward uniform expenses.
- The favorable balance is due to operators not yet using their annual credit. The costs will vary throughout the year depending on when the operator uses his or her uniform credit.

Contracted Services - Unfavorable

- The unfavorable variance is attributed to emergency repair services in August for the CNG station. Additionally, there were seven (6) towing services charged, and semiannual A/C inspection and repair fee.
- Contracted service expenses vary throughout the year (e.g., SVC Towing and Freight in department 22 are utilized on a need basis, web hosting costs, hazardous waste disposal fees, contracted services AC).

Equipment Repairs - Unfavorable

- The unfavorable variance is due to repairs and maintenance to the shop bus lift incurred in August.
- Equipment repair cost vary depending on the needs of the agency (i.e., Shop Equipment, Farebox).

Security Services - Favorable

• Security services are within an acceptable range of the budgeted amount.

Fuel - CNG - Favorable

• Internal consumption has decreased by 19,344 GGE's below FY19 YTD amounts.

The lower internal consumption is primarily attributed the hydrogen station being down earlier in the year. Fuel had to be purchased from an outside vendor and therefore lowered inhouse production.

Early Departures by Route FYTD



Late Departure Percent by Route October





Total Trips vs. Late Cancellations October












RE: Purchase of Four (4) Expansion Fixed Route Buses

Recommendation

Recommend that the Board of Directors delegate authority to the CEO/General Manager to negotiate and execute a contract with New Flyer of America, Inc. to purchase four (4) expansion 40-foot low floor Compressed Natural Gas (CNG) buses. Total cost of the contract will not exceed \$2,724,189, including tax. If approved, the contract will be executed once the Affordable Housing and Sustainable Communities Program (AHSC) standard agreement is completed.

Background

SunLine, along with the City of Coachella and Chelsea Investment Corporation, successfully applied for funding through the Affordable Housing and Sustainable Communities Program (AHSC). This project will significantly improve the regional transportation landscape of the Coachella Valley by building a bus hub and procuring four (4) buses and forty vanpools to help eliminate over 41.6 million auto vehicle miles traveled by residents and workers. As a co-applicant SunLine is responsible for the procurement of four (4) CNG buses.

SunLine will use an existing cooperative purchase agreement to procure the four (4) CNG buses. In 2015, OmniTrans completed a solicitation that included SunLine Transit Agency for the procurement of 40-foot low floor CNG buses, which granted SunLine the ability to purchase up to 24 buses. The contract was awarded to New Flyer of America, Inc. for heavy duty Xcelsior buses. In July 2019, SunLine purchased six (6) of the available options under this solicitation. If approved, this purchase would utilize four (4) of the remaining 12 options.

Financial Impact

The financial impact of \$2,724,189 will utilize the Downtown Coachella Net Zero Affordable Housing and Transportation Collaboration Sustainable Transportation Infrastructure (STI) funds from the State of California.

RE: Purchase of Paratransit Vehicles

Recommendation

Recommend that the Board of Directors delegate authority to the CEO/General Manager to negotiate and execute a contract with Creative Bus Sales Inc. (CBS) for 15 paratransit vehicles. Total cost not to exceed \$2,369,890, including taxes.

Background

SunDial is an origin-to-destination advanced reservation transportation service for persons with disabilities. SunDial's paratransit fleet currently consists of 39 Ford Cut-A-Way CNG powered vehicles. The Agency has vehicles that have reached the end of their useful life.

The ARBOC Spirit of Freedom paratransit bus was selected because they are comparable with the current SunDial paratransit fleet. CBS is an authorized dealer for ARBOC Specialty Vehicles and were awarded the contract under the Department of Enterprise Services ("Master Contract") through the State of Washington.

The Master Contract gives smaller agencies the ability to purchase a variety of different vehicle options at very competitive pricing. Access to purchase from this agreement is limited to publicly funded agencies, city transit systems and non-profit organizations that provide governmental services. The Master Contract meets all of the FTA's requirements governing third party contracting. Vehicle assembly and delivery schedule is expected to be 120 days from award of contract.

Financial Impact

The financial impact of \$2,369,890 was budgeted in the FY17 through FY20 SRTPs, utilizing Federal Transit Administration 5307 & State Funds will be used to pay for these vehicles.

RE: Fiscal Year 2019 Audit Reports

Background

SunLine Transit Agency is required to complete annual financial and single audits in accordance with its Joint Powers Agreement, as well as with State and Federal requirements. Beginning in FY 2019, SunLine awarded a contract to conduct these required audits to a new firm, Eide Bailly, LLP. In October, staff submitted an information item to the Board of Directors, informing them that the audit was not yet complete, based on additional requirements that the auditors had to meet, and that it would be presented to the Board for approval in December. In previous years, the audit was completed and submitted to the Board for approval at the October meeting. The audit team was aware of the timeline for the Board report and the deadline at the end of December for filing the report to the State Controller, and assured staff that they could meet the timelines.

Unfortunately, staff has not experienced appropriate levels of communication and timeliness expected from our audit firm, and learned last week, when the final report was due, that the analysis was not complete and the report is not ready for submittal to the Board. We have expressed our concern and displeasure to the managing partner of the firm and are actively working with them to ensure that the report is completed in the next few weeks so that it can be submitted to the Board in January.

Because the report was not completed in a timely manner, staff has requested an extension from the State Controller to move the due date for the financial audit from December 31, 2019 to February 28, 2020. The deadline for the Federal single audit is March 31, 2020 and does not require an extension.
